Parish Rate requires annual confirmation from the pastor that the family is an active and contributing member of their parish by completion of the Parish Affiliation Form provided.

As such, you remain obligated to pay the tuition and fees outlined herein. There will be no release, refund or rebate of any tuition.

#### **Extended Day Care:**

Early morning care from 7:00 a.m. to 7:35 a.m. is offered at no charge for students in grades K-8. Pre-Registration is not required for AM or PM care. Monthly billing through FACTS. There is no Extended Day Care on 11:10 a.m. early dismissal days or emergency (snow) days. Child-care is tax deductible.

# Grades 1–8<sup>th</sup> Hours 2:30 p.m. to 5:30 p.m.:

One child - \$13.00 per hr., Two children - \$18.00 per hr., Three children - \$23.00 per hr.

PreK 3/4/5 only 7:30-8:30 a.m.; PreK 3/4/5 & K 2:30- 5:30 p.m. - \$15.00 per hr.

#### \* Additional Annual fees (non-refundable, not applied to tuition):

Registration /Parent Association (HSA) Fees - \$300 per family Grade 8 Graduation Fee - \$100 / Gr 8 Student

Volunteer Hours – 30 hours per family with a student in Grades K-8; 15 hours per family with a student only in PreK 3/4/5. Due to COVID hours are encouraged but not required.
