<b><u>Kindergarten – 8<sup>th</sup> Grade</u></b>	<b><u>Parish Rate*</u></b>	<b><u>Non-Parish Rate</u></b>
Family with 1 child.....	\$ 9,895	\$ 10,895
Family with 2 children.....	\$ 19,290	\$ 21,290
Family with 3 children.....	\$ 28,685	\$ 31,685

Families with 4 or more children: Tuition is reduced by \$500 per K-8 sibling.

*\*Parish Rate requires annual confirmation from the pastor that the family is an active and contributing member of their parish by your first tuition billing.*

**Pre-Kindergarten 3/4/5 Year Old Program**

*Pre-Kindergarten students must be age 3 by August 31<sup>st</sup> of the year starting our program.*

4 Full Days 8:30-2:15 (M,T,W,Th 3/4s only) .....	\$ 10,200
5 Days 8:30-12:30 .....	\$ 8,885
4 Days 8:30-12:30 (M,T,W,Th 3/4s only) .....	\$ 8,000

**Additional Annual Fees (non-refundable, not applied to tuition):**

Registration /Parent Association (HSA) Fees - \$335 per family

Grade 8 Graduation Fee - \$300 / Gr 8 Student

Volunteer Hours (*billed at \$20/hour, if not served*)

*30 hours per family with a student in Grades K-8.*

*15 hours per family with a student only in PreK 3/4/5.*

Please understand that the School's financial obligations do not change if a student withdraws, or is dismissed from the School in accordance with the School's disciplinary procedures. As such, you remain obligated to pay the tuition and fees outlined herein. There will be no release, refund or rebate of any tuition or fees.

**Extended Day Care:**

Early morning care from 7:00 a.m. to 7:35 a.m. is offered at no charge for students in grades K-8.

You may be eligible for the child dependent care credit for these expenses. Consult your tax advisor.

**Grades 1– 8<sup>th</sup> Hours: 2:30 p.m. to 5:30 p.m.**

One child - \$15.00 per hr., Two children - \$20.00 per hr., Three or more children - \$24.00 per hr.

**PreK 3/4/5 only 7:30-8:30 a.m.** - \$16.50 per hr.

**PreK 3/4/5 only 2:30-4:30 p.m.; K 2:30- 5:30 p.m.** - \$16.50 per hr.
